A. Introduction

These Terms of Service govern access to and use of the ElderWall AI: Smart Wallpapers (“App” or “Service”) by individuals who are general visitors to the App owned or operated by Xingyun Feng. (“we”, “us”, or “our”). By using our Services, you accept these Terms.
